1. BELLES AFTERCARE CENTRE (PTY) LTD

Belles Aftercare Centre (Pty) Ltd (Belles) is an independent business providing after school and term holiday care facilities for pupils of St Mary's Junior School.

2. SERVICES

2.1 Belles undertakes to provide, in general, good care to the children in its care and in so doing, shall cater for their physical wellbeing by, *inter alia*, providing cooked meals, supervising their play and social and educational activities, including homework, after school has closed. Programmes are also run off campus for pupils of St Mary's Junior School and their siblings during school term holidays. No aftercare is available during half-term breaks or public holidays.

3. MISSION STATEMENT

Belles subscribe to values and ethos of St Mary's School in the conduct of its business and in the provision of its aftercare services.

4. CODE OF CONDUCT

Children shall be subject to the Code of Conduct of St Mary's Junior School; a copy of which will be provided by the school.

5. HOURS

- 5.1 Belles shall maintain the following hours from Mondays to Fridays:
- 5.1.1 During school terms between 12h15 and 17h30.
- 5.1.2 During school holidays between 07h30 and 17h00 (Off campus).
- 5.2 If children are not collected by, or on behalf, of their parents or guardians within the times mentioned, they shall remain in the care of Belles Aftercare Centre on the premises, in the care of the caregivers until such time as they are collected and subject further to the qualification that, should the parents/guardian not collect the children by 18h00 and Belles be unable to obtain instructions from the parents or guardians of such children, Belles shall be entitled to take such children to the boarding house at St Mary's, until such time as the parents or guardians are able to collect such children.
- 5.3 We are open as usual on all break-up days.

6. MEDICAL

Should any children require urgent medical attention, Belles in the first instance shall refer the children to her/his designated medical practitioner. Should this medical practitioner be unavailable, and the parents or guardians of such children also are unavailable to give alternate instructions, Belles shall refer the children to a medical practitioner designated by the school.

8. HOLIDAY CARE

Holiday care will be available at an additional fee during all school term holidays except for the half-term breaks. This will be held at Saheti School in Senderwood and not at St Mary's School.

9. LATE COLLECTION

There will be a late collection fee of R200 per child **per 15 minutes late** or part thereof. Fines are payable immediately.

10. PUBLIC HOLIDAYS AND HALF TERMS

We will be closed on all public holidays and half term breaks.
